6.0 Hon Treasurer's Report

- 6.1 End of Oct balance £5214 Junior Fund £810 .40
- 6.2 More charity donations were received for the Charity at the AGM consequently £192 .97 will go forward to next year's charity.
- 6.4 Equipment sales for the year look good a stock take needs to take place before the end of the year.
- 6.5 JD listed the outstanding defaulters CS emphasised that the charge is not a fine but a contribution towards the costs of the rally.
